bans organohalogen flame retardants in electronic consumer goods

**EUROPEAN COURT**  
confirms European Ecodesign regulations banning all halogenated flame retardants in enclosures and stands of electronic displays

**WASHINGTON STATE**  
proposes regulation to ban all halogenated FRs in consumer electricals

**CANADIAN REGULATORS**  
restrict Deca ethane (DBDPE), the second largest brominated flame retardant
